Agency presentation: Tri-County Care – Cheryl Marron, Resource Team Specialist	designated Care Coordination Organizations (CCOs) in New York State. CCOs employ care managers that address the comprehensive care needs of individuals with intellectual and developmental disabilities. Tri-County Care covers over twenty counties in a region ranging from Warren and Washington south through New York City and Long Island. C. Marron talked about an regional resource network they are developing. They have forms for agencies to include their contact information and services provided. This will assist their care managers in linking people to needed services. She also talked about a private foundation she founded – Flutters of Hope, Inc. that addresses eating disorders.	
Agency workforce updates	Jason states the Liberty House is doing well on staffing, although they have an opening for a Benefits Specialist, due to a recent resignation. Chrissy stated CWI is having retention issues and have many DSP positions open.	
2024-25 NYS Enacted Budget	Rob reviewed an analysis document from the Albany Strategic Advisors regarding the 2024-25 enacted budget highlights pointing out the Human services COLA on page 6 and the OPWDD appropriations on page 11.

2025 Local Services Planning process	 Rob provided an overview of the 2025 Local Services Planning process. The state now requires a 4-year Local Services Plan, with annual updates. They are in the process of releasing guidelines and surveys for the current planning cycle. The 2024-27 Local Services Plan has been posted to both the County websites. With Transportation being a big issue, Stephanie stated that Washington County OFA & DSS will provide non-medical transportation on case by case basis. They are in the process of hiring a new worker to facilitate ½ their time at NY Connects and ½ their time with transportation.
