OFFICIAL ABSENTEE BALLOT FOR GENERAL ELECTION - HOW TO VOTE

HOW TO RETURN MILITARY BALLOT

1. Mark in pen or pencil.
2. To vote for a candidate whose name is printed on this ballot, make a single cross **x** mark or a single check **✓** mark in the voting ovals to the right of the candidate's name.
3. To vote for a person whose name is not printed on this ballot, write or stamp his or her name in the space that appears at the bottom of the column containing the title of the office.
4. Any other mark or writing, or any erasure made on this ballot outside the voting ovals or blank spaces provided for voting will void this entire ballot.
5. To vote on a proposal, see reverse side of ballot and make a single cross **x** mark or a single check **✓** mark in one of the ovals contained in the box setting forth such proposal.
6. Do not over vote. If you select a greater number of candidates than there are vacancies to be filled, your ballot will be void for that public office or party position.

7. If you tear, or deface, or wrongly mark this ballot, call the Board of Elections at (518-761-6456) for instructions on how to obtain a new ballot. Do not attempt to correct mistakes on the ballot by making erasures or cross outs. Erasures or cross outs may invalidate all or part of your ballot. Prior to submitting your ballot, if you make a mistake in completing the ballot or wish to change your ballot choices, you may obtain and complete a new ballot. You have a right to a replacement ballot upon return of the original ballot.
8. **To be counted, absentee ballots returned by mail must be postmarked no later than the day before Election Day and be received by the Board of Elections no later than 7 days after Election Day.**

1. After voting the ballot, fold such ballot and enclose it in the envelope bearing the voter's Statement, and seal the envelope.
2. Fill in properly the blanks in the Statement and sign your name.
3. Enclose the sealed envelope bearing the Statement in the envelope addressed to the Board of Elections and mail promptly.
4. The ballot of the **MILITARY VOTER** must be postmarked no later than the day before Election Day and be received by the Board of Elections no later than thirteen days following the day of a general election to be cast and counted.
