#### ***What is the Deductible Reimbursement Plan?***

This plan allows participants in the employer-sponsored BSNENY HDEPO 6310 Health Plan to be reimbursed for specific out-of-pocket healthcare related expenses that are approved by the BSNENY health plan and applied towards the annual health plan deductible. Expenses must be incurred by your or your eligible dependents that are covered under the BSNENY health plan (spouse, dependent children).

#### ***How does the Healthcare Deductible Reimbursement Plan work? How do I get reimbursed?***

When you incur healthcare expenses that are subject to the deductible, BSNENY will send deductible information directly to Jaeger & Flynn Associates. We will then reimburse you for any out-of-pocket deductible expenses up to the available balance through the Deductible Reimbursement Plan only. ***There is no documentation required!*** Just simply incur the expense and know that reimbursement will automatically be generated for you.

Once the Deductible Reimbursement Plan is exhausted, you are responsible for any remaining deductible or copayments not covered by insurance.
