- Certified for Medicare and Medicaid Programs
- Medicare and Medicaid are billed directly for services provided for qualifying individuals
- All Commercial Insurances with Home Care Benefits Accepted
- Cost of Services are Billed Directly to Insurance carriers at Previously Negotiated Contract Rates
- Private Pay and Sliding Fee Schedule Available
- Documentation of Medical Need is Required for Service
- Client must have a Community Physician to Order and Sign Home Care Orders
