**NY Connects** is a statewide, locally based “No Wrong Door” entry system providing one stop access to free, objective, and comprehensive information and assistance on long term care services and supports.

A long term care council (LTCC) must exist in each county to conduct long term care system planning and development to ensure achievement of the goals and objectives of NY Connects.

The Council reports their activities and recommendations to the lead agency, who is required to report directly to the county chief elected official, legislative board, or their designee.
