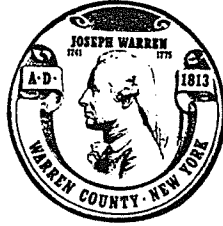

## STATEMENT OF CANVASS PRESIDENTIAL PRIMARY Election APRIL, 19<sup>TH</sup>, 2016


