<p><u>Agency/Program Presentations:</u></p> <ul style="list-style-type: none"> ✓ CHAMP (Community Health Access to Addiction and Mental Healthcare Program) Joyce Porter, EASE Program Manager, Adirondack Health Institute ✓ Warren/Washington ACT (Assertive Community Treatment) Team Owen Allie, LMHC, Team Lead, Warren/Washington ACT Team Northern Rivers Family Services 	<p>CHAMP is a joint effort of OASAS and NYS OMH to create an ombudsperson program. It was established in partnership with community based organizations, including Community Service Society, Legal Action Center, the NYS Council for Community Behavioral Healthcare, Legal Aid Society and the Medicare Rights Center. CHAMP can help recipients and family members by listening, educating, empowering and advocating to address barriers to treatment. Helpline representatives can assist with concerns regarding insurance, access to medication and treatment, denial of services, parity/coverage and discrimination issues, system navigation, medical benefits and enrollment referrals and legal assistance for insurance appeals in a timely and respectful manner. CHAMP Helpline-1-888-614-5400-Monday-Friday-9am-4pm.</p> <p>EASE (Enrollment Assistance Services and Education) serving 7 counties (Clinton, Essex, Franklin, Hamilton, Saratoga, Warren & Washington) 1-866-872-3740 or 1-855-650-0112 AHI 101 Ridge St., GF NY 12801</p> <p>The ACT team, operated by Northern Rivers, is located at 375 Bay Rd. Queensbury and shares space with the Northern Rivers Mobile Crisis Team. The ACT team provides treatment, rehabilitation, and support services to individuals in Warren and Washington counties diagnosed with a severe and persistent mental illness. They have a 48-slot capacity and serve individuals 18 years and older. Their mobile, multidisciplinary team works with clients in community settings to help them achieve personally meaningful goals and life roles. Referrals go through the Office of Community Services Single Point of Access (SPOA). They also provide the Care Coordination component, working with AHI. 2020 Local Services Planning Cycle	R. York stated the office is engaged in the development of the 2020 Local Services Plan (LSP), which is due to the State in June. Carrie Wright and Crystal Lawrence will coordinate a PDF to be sent via email for review and feedback.	
2019 – 2020 NYS Budget Updates	R. York provided updates regarding the 2019-2020 NYS budget process. He reviewed an enacted budget summary/analysis memo from the Conference of Local Mental Hygiene Directors (CLMHD). Several items of note were highlighted.	
Medicaid Managed Care Issues: ✓ DSRIP BH-related project updates	<p>J. Neifeld said they are serving as the lead applicant for DSRIP/AHI Innovation Funds for a community-wide transportation program for non-medical appointments, providing bus tokens, gas cards, etc. They are partnering with GGFT and Tri-County United Way for this project.</p> <p>Also, Baywood Center and Alliance for Positive Health have teamed up with the YMCA for a fitness program with family care, after-school care and camps for children and youth for wellness and socialization. They will provide a peer advocate, fitness coach, nutrition component and transportation along with a bi-monthly dinner for participants.</p> <p>Another DSRIP/AHI approved program was the re-entry ABLE program for inmates released from jail. Kickoff in May 2019 with 9 month funding. Currently they have had 29 people in the 1st Quarter with 18 having services.</p> <p>S. McManus stated CFP & CFR GF put in for DSRIP Innovation Funding to replace the OASAS Diversion funding that was cut in order to continue Programming.</p>

They are also working on development of a Men’s Program, more to come as it develops. Under the new 820 regulations, these will provide Rehabilitation and Stabilization services.</p> <p>R. York discussed the NYS Opioid Response (SOR) Grant increasing access to addiction treatment services in rural communities. It’s a one-time funding of up to \$150,000 for each County that providers will be requested to develop a proposal and budget justification for funds for the expansion of Medication Assisted Treatment (MAT) services.</p> <p>R. York discussed the Jail-based SUD treatment funding of \$60,000 for each County.</p> <p>Carrie Wright, co-chair of the task force, states they continue to hold monthly meetings. There is good buy-in from criminal justice system partners. <p><u>Agency Updates:</u> Baywood Center/820 River St.</p> <p>AMH</p> <p>Center For Recovery HF</p> <p>PEOPLE, USA; Rose House</p> <p>OFA</p> <p>AHI</p>	<p>Those in attendance were given a chance to provide updates as follows; Jen N. stated Baywood has a new Outreach Counselor, Ashley. All sites are doing well. They have 9 FT staff; and are providing evening programs at the HF Annex. 820 River St. is looking for uses for the Granville Women’s’ site and is considering bringing community services agencies in to that space. Peter N. added their organization is stable, committed, and are not going anywhere. They will continue to find ways to serve the community.</p> <p>Andrea D. stated their clinic Open Access is doing well. They are looking for grant money for further expansion in schools. They are working hard on the new housing project planned for Glens Falls.</p> <p>Rachel said they had an unexpected 3-day OASAS audit/review. They are correcting any issues that were raised. They have a new 5-year contracted position, Community Resource Liaison starting April 29th at Washington County CPS, more to come as it evolves.</p> <p>David Klippel announced he will be leaving the Glens Falls location. He has been promoted to a new position within PEOPLE USA, and will be based in the Poughkeepsie area. Dillon Swertner, who is currently their Transition Care & Wellness Team Lead, will be stepping in as the Program Coordinator for the Warren Washington Rose House. They average nine guests per month, four hundred warmline calls per month, and currently offer three peer support groups in the community.</p> <p>Stephanie informed us of a survey that was sent out via email that is due by the end of May to Warren & Washington Counties. This is to inform their four-year plan to the state regarding local needs.</p> <p>Rebecca spoke of the Rural Opioid Response Grants. They have two community advisory groups to be held in Lake Placid June 26th & August 15th. A webinar will also be available.</p>
