






COUNTY PLANNING AGENCY

Local law number 3 of 2012 authorized the Planning Department to fulfill the County's obligations pursuant to GML 239 I and m. This report fulfills the Agency's responsibility in accordance with Section 239d paragraph 6 of the General Municipal Law to provide an annual report to the County Board of Supervisors. The County Planning Board function continues to be staffed by the Department of Planning and Community Development. Department staff expended 161 hours of time to complete the Section 239 I and m referrals.



NORTH CREEK RECREATION TRAIL PLAN

Town of Johnsburg/Chazen Companies & Wilderness Property Management, September 2019 Funding Provided by Local Waterfront Revitalization Program Grant (NYSDOS) C1000976

This report identified opportunities for expanding and improving the Town of Johnsburg's recreational trail network and associated amenities. The final plan creates a vision and provides direction for improving the local economy through promotion of the abundant outdoor recreation opportunities in North Creek.

Key findings include:

- Raymond Brook Valley Proposes the creation of a new multi-season backcountry trail system, which would include the installation of warming huts and a mountain biking area connected to Ski Bowl Park
- Improve Ski Bowl Park Area Improvements include enhancements to the beach area, securing access to trail connections, and safety improvements on Route 28 to improve the connection between the Hamlet of North Creek and the park
- **Obtain Easements and Approvals** To make the proposed trail system viable it will be necessary to secure easements and approvals from private property owners and the state.
- Community Connections This phase would create larger loops for multi-day experiences
- "Basecamps" Development The establishment of these areas would provide social gathering and shelter locations.



TOWN OF HORICON FIRST WILDERNESS PLAN

Town of Horicon/The LA Group & Clothier Planning and Design, October 2019 Funding Provided by Local Waterfront Revitalization Program Grant (NYSDOS) C1000976

The First Wilderness Heritage Corridor is a regional economic development initiative developed and managed

by the Warren County Planning Department. The Town of Horicon recently became eligible for inclusion in the First Wilderness Heritage Corridor and this study was commissioned to develop a feasibility study regarding its inclusion. The study identified thirty three priority actions, including:

- Request that the NYS Legislature add Brant Lake to the list of Designated Inland Waterways
- Identify a location for a Brant Lake boat wash station
- Design and Construct a Mill Pond Walkway
- Conduct a Feasibility Study for reusing the Adirondack School House Community Building

Town of Horicon/ The LA Group & Clothier Planning and Design, June 2019 Funding Provided by Local Waterfront Revitalization Program Grant (NYSDOS) C1000670



Building on two key priorities of the First Wilderness
Heritage Corridor – inter-municipal cooperation and
promotion of outdoor recreation – the Planning Department
has led an effort to lay out a 99 mile wilderness trail
stretching from the Town of Corinth to the hamlet of
Tahawus. The proposed trail network would use a blend of
off-road trails and low-traffic dirt and paved roads. The
report concludes that the trail could be completed by
utilizing existing trails and roads and constructing
approximately 25 miles of new off-road trails. A Blueway
(waterbased trail) has been proposed for the southernmost
portion of the trail.

CHESTERTOWN TO POTTERSVILLE TRAIL PLAN

Town of Chester/The LA Group & Wilderness Property Management, February 2019 Funding Provided by Local Waterfront Revitalization Program Grant (NYSDOS) C1000561

The First Wilderness Heritage Corridor Program prioritized the development of a plan to determine the best route to link the two main hamlets in the Town of Chester, Chestertown and Pottersville. Key findings of the report include identifying two alternatives for connecting the hamlets – one off-road and one on-road – as well as identifying a potential route to connect the hamlet of Pottersville with Scaroon Manor.







TOWN OF CORINTH TRAIL LINKAGE PLAN

Town of Corinth/The LA Group & Wilderness Property Management, March 2019
Funding Provided by Local Waterfront Revitalization Program Grant (NYSDOS) C1000561

This plan was undertaken to determine the best route to connect the Upper Reservoir Recreation Area to the public park and beach along the Hudson River. The report identifies both off and on road alternatives for the connection. It also identifies the regulatory approvals needed and potential funding opportunities.







COUNTRYSIDE BUILDING ASSESSMENT STUDY

Warren County, Beardsley Architects and Engineers, June 2019
Funding Provided by Community Development Block Group Program (NYS CDBG 1197CP66-17)



Warren County, through the Planning
Department, prepared a funding request to
undertake a comprehensive building study of
the County's Countryside Adult Home in
Warrensburg to understand the building needs
and establish improvement priorities. Reliable
information is necessary to determine the
appropriate level of public investment required
to extend the useful life of this facility for lower
income persons – primarily the elderly. The
County was awarded grant funding in the
amount of \$43,237 and provided a 5-percent
cash contribution towards the studies. Warren

County, through the Housing Repayment Account, managed by the Warren County LDC, provided \$4,103.50 as the required local match.

Beardsley Architects and Engineers, with Jade Stone Engineering, completed the Building Condition Assessment Report. Additionally, a Limited Asbestos and Lead Survey were completed by Atlantic Testing Laboratories. Both studies were completed in June 2019. Cost estimates and prioritized repairs were identified and will be utilized in the County's 5-year Capital Projects Plan.

High Priority items include:

- ADA signage at handicap parking, repair the steel railing bases at the stairs, and install a dedicated concrete walkway
- Investigate the concrete slab in the living room; infill the sloping floor
- Repair or replace unit ventilators, exhaust fans, building pumps, pneumatic controls to DDC, add ERV's and ductwork for ventilation, and repair the fireplace flue
- Replace the electrical generator and fire alarm system
- Add a water softening system and replace broken hose bibs



CLIMATE SMART COMMUNITIES PROGRAM

On June 24, 2019, The Warren County Board of Supervisors unanimously adopted the Climate Smart Communities Pledge, earning Warren County the designation of a Registered Climate Smart Community. Later in the year, members were appointed to the Warren County Climate Smart Task Force, coordinated by the

Assistant County Planner. The purpose of this group is to review, prioritize and implement



actions to mitigate the influencing factors of global climate change as well as reduce their anticipated impacts. In 2020, the group will undertake a number of planning and assessment projects that focus on adapting to a changing climate. Additionally, staff will look to procure funding to build a more climate resilient county and reduce contributions of greenhouse gas

LAKE GEORGE PARTNERSHIP

In 2019, steps were taking to abandon the structure of the Lake George Watershed Coalition. However, there was strong consensus to establish a new organization to discuss common issues, improve the coordination of funding applications, and identify solutions – at the watershed level. This informal group, the Lake George Partnership, was formed and is expected to become an example of effective collaboration. Staff members Chris Belden, Assistant County Planner, and Amanda Beck, Junior Planner, are members of the group.

CENSUS 2020 COMPLETE COUNT COMMITTEE

Warren

County

The Warren County Planning Department continues to prepare for the approach of Census 2020, with Census Day taking place on April 1, 2020. Warren County's population is estimated to decline from the 2010 census. It is critical that the County gets a complete, accurate count of its population so we lose out on

as little public funding as possible. Census population figures are used to determine the distribution of over \$675 billion in federal funding for a wide array of programs. Each resident of the County is worth approximately \$3000 in federal funding, which means that an undercount of just one percent could result in a loss of funding of nearly \$20 million dollars for our County over the next decade.

For the first time ever, Census 2020 will allow an online response. While this should make answering the Census easier for a large portion of the population, it also poses challenges for our rural and elderly populations. Other historically undercounted populations include young children and renters. To help ensure that every Warren County resident is counted, the Planning Department has established a Complete Count Committee, made up of representatives from local school districts, churches, non-profit organizations, local governments, county agencies, and Census Bureau staff. The committee has been meeting once monthly since November to discuss strategies for encouraging local residents to complete the Census.

In December 2019, the State of New York indicated that it would provide nearly \$100,000 in funding for Census outreach activities for Warren County. Hopefully those funds will become available soon. The current task of the Complete Count Committee is to develop a comprehensive outreach plan for reaching our hardest to count populations. ADIRONDACK GLENS FALLS TRANSPORTATION COUNCIL

The Planning Director continued to serve on the AGFTC Planning Committee and as an alternate on the Policy Committee. The Planning Director provided input and assistance on numerous projects and activities during 2019 including the Village of Greenwich Main Street Streetscape Plan, Ski Bowl Park access analysis, Fire Road / Webster Avenue signals analysis, Bridge preservation analysis update and several amendments to the TIP. The Director provided approximately 35.5 hours of assistance to AGFTC in 2019.

Planning Department staff also provide GIS Technical Assistance for A/GFTC. This time is reimbursed. GIS Staff spent 38 hours during 2019 completing projects for the Adirondack/Glens Falls Transportation Council. Projects included updating the interactive route map for Greater Glens Falls Transit, providing demographics for a project with the Conkling Center, providing training in data collection for other state Metropolitan Planning Organizations, updating maps for the Long Range Plan, and updating data for A/GFTC's traffic model. The largest project completed was the design and implementation of an interactive online dashboard for A/GFTC's transportation improvement plan, which can be found here: https://warrencountyny.gov/agftc_tip.

LAKES LWRP GRANT PROJECTS

Watershed Grant Management

Since 2017, the Warren County Planning
Department, led by Chris Belden, Assistant
County Planner, has submitted funding
applications and overseen the
implementation of critical water quality
projects in the Lake George and Schroon Lake
watersheds.

Village of Lake George – Watershed Project Grants

Warren County is currently assisting with administration of two contracts (2012 and 2014 awards), awarded to the Village of Lake George, for priority water quality projects. The Planning Department worked with the Village, NYSDOS, and the project partners to revise the contracts, which were executed in the fall of 2018. The grant amounts total \$925,250 and cover boat inspections, invasive species eradication, erosion and sediment control, road salt management, and a study to quantify the benefits of the West Brook Project. In 2019, communities and organizations working to improve the water quality of Lake George:

- Continued the implementation of the boat inspection program on Lake George;
- Harvesting of invasive Eurasian watermilfoil; and
- Purchased equipment for local highway departments for the purpose of reducing road salt in Lake George.

2017 Invasive Species Grant

In 2017, the Planning Department submitted

a funding application to assist with eradicating all dense beds of Eurasian watermilfoil, an aquatic invasive species, from Lake George. The County has been awarded \$600,000 and the contract was executed in 2019. This funding has been crucial in knocking back the spread of dense beds of invasive Eurasian watermilfoil on Lake George.

2018 Schroon Lake Comprehensive Boat Inspection Program

In 2018, the Planning Department applied for and was awarded \$289,750 on behalf of the towns of Horicon, Chester and Schroon Lake to support a comprehensive boat inspection and decontamination program around Schroon Lake. The contract is expected to be executed in early 2020.

2015 Comprehensive Watershed Action Plan for Lake George

In 2015, the Town of Queensbury was awarded funding on behalf of the communities in the Lake George Watershed for the purpose of developing a Comprehensive Watershed Action Plan, which has not been undertaken in over thirty years. The plan will bring together a diverse set of stakeholders to define the vision, actions, and implementation strategy for preserving water quality on Lake George. The project was in jeopardy of not being implemented, however, through the assistance of the Assistant County Planner, the project budget was modified and a clear source of match was identified. The contract is expected to be executed in early 2020. The Lake Champlain-Lake George Regional Planning Board will be responsible for the development of the plan and the Planning Department will provide administrative services.

FIRST WILDERNESS LWRP GRANT PROJECTS

In 2019 planning department staff managed five New York State Department of State local waterfront revitalization grant awards for the First Wilderness Heritage Corridor. These grant awards had a balance of \$2,704,204 remaining in unexpended funds at the start of 2019. Additionally, the department staff submitted close out paperwork for three other grants and secured

final reimbursement payments from the state. Administration of these programs comprised approximately 2814 staff hours accounting for nearly 30% of productive staff time. Grant funds expended in 2019 amounted to **\$1,185,937**.

2013 Project Award: program activities in 2019 saw the completion of work at the Adirondack Folk School in Lake Luzerne and trail work at the Dean Farm property in Stony Creek. This grant was extended through the 2020 building season in order to

allow for completion of final work programs at Dean Farm. Funding expensed in 2019 in furtherance of grant activities amounted to \$137,715.

2014 Project Award: activities undertaken in 2019 included completion of the trail linkage design between Chestertown and Pottersville. Work also commenced on the design of the Stony Creek Community Center to be located on the Dean Farm property. This grant award received an extension through the 2020 building season in order to allow for a coordinated approach to multiple grant awards for streetscape work in the North Creek business district. Funding expensed in 2019 for eligible grant activities amounted to \$486,581.

2015 Project Award: significant progress was made on the number of elements in this grant award. The layout of the First Wilderness trail was completed with

a suggested route connecting the town of Corinth to Tahawus. The town of Warrensburg made significant progress on the conversion of the old firehouse to a community center. Final details at the community center will be completed in 2020. The town of Warrensburg also completed activities at two other

> local Parks that were funded as part of this application. This grant award also has funding for improvements to the streetscape in the North Creek business district and that will be coordinated with activities in the 2014 and 2016 awards. Funding expensed in 2019 for eligible grant activities amounted to \$355,323.

2016 Project Award: in 2019 final trail work was completed at the Harris preserve in Lake Luzerne with the way finding signage to be completed in 2020. A planning study was completed for the town of Horicon identifying ways to use the recreational resources of community in furtherance of economic development. Design work at

Creek Ski Bowl was

substantially completed identifying opportunities for connecting the Ski Bowl with the hamlet and with existing trail networks to enhance its appeal to recreation users. Significant progress was made utilizing in house resources and consultant services for social media marketing efforts for the first wilderness corner. Combined with funding from the 2013 and 2015 awards it is anticipated that streetscape work in North Creek will be completed in 2020. Funding expensed for this grant in 2019 amounted to \$206,318.

SMART GROWTH GRANT PROJECTS

The Planning Department was awarded a Smart Growth Grant from the New York State Department of Environmental Conservation in 2016 in the amount of \$70,436 to promote the First Wildernes communities. In Spring 2019, the Planning Department issued a Request for Proposals for many of the elements within the work plan and hired local design firms Advokate and Sidekick Creative to complete several projects within the scope of work. Work commenced in June of 2019 and will continue through June of 2020. Additional funding from the 2016 LWRP First Wilderness grant and some occupancy tax money allowed the scope of the project to expand to include additional elements and towns. Projects include:

Update Panel Display in the Lake George Visitors Center The center display in the Lake George Visitors Center features a panel for each municipality in Warren County. It is approximately twenty years old and is long overdue for an update in both content and visual appeal. The Planning Department worked with the Tourism Department and Sidekick Creative to come up a main concept and several side concepts for each community in the County, with the intent of encouraging visitors to visit each of the communities. Planning department staff wrote text with input from the Tourism department and each town, and Sidekick created artwork and graphics and designed the panels. The panels are extremely colorful and visually appealing. The main artwork on each panel was so well-received that the Planning Department investigated producing the artwork as posters that can be purchased by the general public. These posters were produced in early December and are for sale at the Planning Department, the Historian's office and at the

Warren County Historical Society for \$10. The public response has been very enthusiastic to date. The panels will be installed in the Visitors Center in time for the Winter Carnival weekend in February. GIS Staff also created a map of each community, and 8.5x11 versions of the panels, with a map on the flip side, were produced and will be available for visitors to take with them. These smaller sell sheets have also been provided to the other area visitor's centers.

Social Media Marketing and Blog Updates for the First Wilderness and the Town of Johnsburg

Advokate established Facebook and Instagram accounts for the First Wilderness and Visit Gore Region. The consultant posts weekly to these accounts and they continue to grow in followers, with the intent of drawing visitors to

the region. In addition, Advokate has been writing weekly blog posts for the visitgoreregion.com website on a wide variety of topics.

Letterboxing Trail The final component of the Smart Growth grant includes the development of a Letterboxing Trail, which is a fun activity similar to geocaching but involving a search for boxes containing hand carved stamps. This task is being completed in house and will be released for the summer season of 2020.


Countryside Wastewater Connection

Warren County received a \$400,000 funding award in 2014 from the NYS Housing Trust Fund Corporation to undertake a sewer connection from the Adult Home to the Town of Warrensburg Wastewater Treatment System and eliminate the existing in-ground septic system. This installation project was undertaken with the assistance from the Town of Warrensburg Water Department, the Warren County Department of Public Works and directional boring services acquired through the public bid process. Warren County provided an additional \$300,000 for the completion of this project. The Director of the Countryside Adult Home has reported that the sewer connection was completed during the first week of January 2020. The tanks from the existing septic system have been emptied and will be back-filled. The County is awaiting NYS DCE certification on final abandonment of the septic tanks.









MAPPING AND GIS

Warren County GIS is responsible for maintaining the County's GIS data sets and online GIS presence, including the Community Map, Imagemate Online, the Recreation Mapper and several other widely used applications. GIS maintenance accounts for approximately one quarter of staff GIS time. In addition, GIS staff has responsibility for assigning e-911 addresses and updating and maintaining the address point, road centerline, and district boundary data used in the County's e-911 Call Center, as well as in other applications.

The County GIS provides technical assistance and mapping support for other County departments and the local Towns, and has technical support contracts with both Adirondack/Glens Falls Transportation Council and the Lake George Park Commission. The addition of Amanda Beck to the department's staff in April 2019 increased capacity for GIS projects and freed up some of the GIS Administrator's time to take the lead on planning projects, in particular the preparation for Census 2020 and the Smart Growth grant.

Minor GIS projects completed during 2019 include:

- A new map atlas and a Polling Location app for Board of Elections
- A new map of Lake George Village for summer tourists for use by the Visitors Center and Chamber
- A map for the Warren County Historical Society's new Warren360 exhibition
- A series of maps of trails and historical locations for Stony Creek
- An online lookup application for use by the local town zoning staff
- Trail GPS and mapping for several new trails

MAJOR GIS PROJECTS - 2019

History and Culture Mapper

Warren County GIS announced the launch of the History and Culture Mapper in mid-October of

2019. This project was funded through the 2016 LWRP and is a sister application to Warren County's Recreation Mapper released in 2018. The format and layout of the applications are similar; however, the History and Culture Mapper may interest a completely different

audience. The History Mapper includes an interactive map, photos, brief descriptions, links, and driving directions to various historical and cultural locations within the County. It is both desktop and mobile friendly and has a GPS-enabled tool that can be used while in the outdoors

Included in the Mapper are locations for sites on the National Register, historic markers, cemeteries, museums, as well as art galleries and

theaters. Another added feature is the self-guided tours, which take visitors along a strategic journey through history. Junior Planner Amanda Beck visit each site and took nearly all of the 600 photos in the application. The County Historian and all of the

local municipal historians were invaluable sources of help throughout the project, and its release was met with much enthusiasm. The application will continue to be edited and updated by the Warren County GIS department.

Capital Improvement Project Inventory

Working under direction from the County Administrator's office, Warren County GIS set up an online survey to collect information about needed Capital projects from all of the County's municipalities and other funded entities, such as the Civic Center, SUNY Adirondack, and the Airport. The resulting data was organized and developed into an interactive dashboard application, which allows users to sort and display projects by entity, phase, type, location, and a variety of other factors. GIS staff will work on refining this application over the course of 2020 to help prioritize and develop the County's Capital Improvement Plan.

Infrastructure Mapping

Over the fall of 2019, GIS staff worked to consolidate all of the existing sewer and water infrastructure data for the towns of Lake Luzerne, Johnsburg, Warrensburg, Hague, Bolton, and Chester, whether it be in hardcopy drawings, GPS data, CAD drawings or already in the GIS. The department also purchased two new handheld GPS receivers with the intent of making on available for use by town sewer and water staff.

COLLABORATION

Working with local organizations towards common objectives is a backbone of the Department of Planning and Community Development's philosophy of collaboration. In 2019, the Assistant County Planner, Chris Belden, established the Warren County Climate Smart Task Force with the goal of prioritizing actions geared towards mitigating the impacts of climate change. In addition, in preparation for the 2020 Census coming up in April, Chris Belden and Sara Frankenfeld established the Census 2020 Complete Count Committee to help ensure Warren County achieves a complete count of its population during the federal Census.

LOOKING FORWARD TO 2020 AND BEYOND...

The Warren County Planning Department enters the new decade with much on its plate. With the potential for the loss of 110+ years of experience in the next 12 months due to retirements, it is critical that additional staff be brought on board to allow for sufficient training and experience to carry out departmental responsibilities. This goal is ongoing. Projects on tap for 2020 include:

Climate Smart Communities Last year, the Warren County Planning Department was unsuccessful in its application for funding to undertake a number of certification actions (planning/assessment-related). However, in 2020, the Climate Smart Task Force under the direction of the Planning Department will work to implement these actions. Once the next round of funding opportunities is announced, the Planning Department and Task Force will consider submitting for other projects.

ADA Transition Plans The Warren County Planning Department has worked

with communities in the past to develop federally mandated Americans with Disabilities Act (ADA) Transition Plans. These plans develop effective strategies for improving public infrastructure, such as sidewalks and curb ramps, to ensure efforts are being made to eliminate barriers for persons of all physical abilities. The County Planning Department has compiled an inventory and assessment of pedestrian related facilities throughout Warren County. Communities are invited to seek the assistance of the County Planning Department for developing these plans.

Comprehensive Watershed Action Plan for Lake George In 2015, the Town of Queensbury was awarded funding on behalf of the communities in the Lake George Watershed for the purpose of developing a Comprehensive Watershed Management Plan, which has not been undertaken in over thirty years. The project was in jeopardy of not being implemented, however, through the assistance of the Assistant County Planner, the project budget was modified and a clear source of match was identified. The contract is expected to be executed in early 2020. The Lake Champlain-Lake George Regional Planning Board will be responsible for the development of the plan and the County Planning Department will provide administrative services.

Warren County Housing Needs and Market
Study Warren County Supervisors have expressed
concern as to the need for new housing that meets
the changing demographics of the communities –
particularly in rural towns. The Planning
Department, in cooperation with the Warren
County EDC, will undertake a Housing Needs and

Market Study that analyzes the existing housing supply, quantifies the need for work force housing and determines the demand for new housing construction by type and location. Funding for this project is intended to be provided in-part by the Warren County LDC through the Housing Repayment Account and with a funding commitment by the Warren County EDC. It is intended that this study would

Warren County Strategic Plan The existing
County Comprehensive Plan was adopted in 1978.
Since that time, numerous county planning and
policy documents have been developed or
implemented. While these documents are
necessary for advancing specific areas of focus,
Warren County would hugely benefit from a more
comprehensive planning document to ensure
greater cohesiveness and efficiency. Long-term
planning can improve a community's resilience to
economic variability and more effectively direct
resources in the community. In 2020, The Warren

Census 2020 The decennial federal Census is coming up on April 1. The Planning Department will continue to lead efforts with the Complete Count Committee to ensure that the County achieves a full count of its population.

Letterboxing Trail GIS staff continue to work towards the early summer release of a Letterboxing Passport and trail. This will be an exciting new activity geared towards getting visitors and residents out and about and exploring parks, trails, and cultural and historic locations in the First Wilderness communities.

GIS Infrastructure Warren County GIS will continue the infrastructure project began in 2019. Tasks for 2020 include creating an online application for town staff to access sewer and water data in the field, provide GPS training for

town staff, and allowing staff to check out a GPS receiver to update their data while in the field.

Capital Improvement Plan Planning Department staff will work with the County Administrator's office to develop the written document for the County's Capital Improvement Plan. The County has set aside funding to advance the readiness of a select number of projects. The Department will seek to leverage these funds to secure additional State funding.

Ensure the Continued Successful Delivery of Grant Programs Planning Department staff intend to close out the remaining tasks in the First Wilderness LWRP awards from 2013, 2014, and 2015, as well as the Smart Growth grant.

Continue to Seek Funding for Capital Projects

Most of the grant programs now require some form of match or require a third party assessment of need condition. The department will continue to advance projects as opportunities arise.
