Commencing the agenda review as follows:

- I. Call to Order by Chair Meeting called to order by Robert Iusi, *Director, Warren County Probation*, at 2:06 p.m.
- II. Roll Call Roll called; guorum was established.
- III. Opening Statement by Chair Mr. lusi extended his appreciation to the members for their participation.
- IV. Reading and Motion to Approve Minutes from January 25, 2023 meeting Motion was made by Mr. Armstrong, seconded by Ms. Palmer and carried by a unanimous vote of those present (Messrs. Anand and Bishop absent).

Motion was made by Mr. Aust, seconded by Mr. McEnaney and carried by a unanimous vote of those present (Messrs.
