




COUNTY PLANNING AGENCY

WARREN COUNTY PLANNING AND COMMUNITY DEVELOPMENT

WARREN COUNTY 2040



In August of 2023, Warren County initiated its first Comprehensive Planning process. The purpose of the planning initiative is to create a unified vision for the future of the county and develop an actionable plan to realize it.







In 2024, the County held 3 public workshops, 8 steering committee meetings, and prepared the draft vision, goals, objectives, and actions for public review. The draft plan is prepared and will be considered for adoption in 2025.



OUTDOOR RECREATION ECONOMY STRATEGIC PLAN

The Warren County Planning
Department and a team of outdoor
recreation planners from SE Group and
Common Ground Consulting are
leading this initiative. The plan will
provide a county-wide perspective on
outdoor recreation priorities for county
government and its many municipal,
business, and nonprofit partners and
identify ways to amplify the economic
impact of outdoor recreation.

In 2024, consultants and planning staff worked to obtain additional public input, developed the existing conditions report, and produced the draft document. The document will be finalized in early 2025.







TRAIL CONNECTIVITY STUDY



In 2022 the Warren County
Planning Department won a
competitive State Economic &
Infrastructure Development (SEID)
grant from the Northern Border
Regional Commission. The award of
\$160,000 is for a modernization and
connectivity study of the trails and
downtowns that connect Lake
George to the Empire State Trail.
This project was launched in 2023
with Barton and Loguidice assisting
with plan development.

The bulk of the study was completed in 2024 with a project advisory committee composed of interested stakeholders of the Warren County Bikeway and Feeder Canal Trail guiding the process. The project team also attended three public events over the summer to seek public input on trail access, safety, and needed enhancements. The final report is scheduled to be released in early 2025.

What is Thriving Hamlets?

The Thriving Hamlets initiative is a comprehensive buildout analysis of the Adirondack Park Agency (APA)designated hamlets in Warren County. This in-depth review utilizes Geographic Information Systems (GIS) to assess buildable land, infrastructure, zoning regulations, and environmental constraints within each hamlet. By combining this analysis with local coordination, the program seeks to identify practical and targeted infrastructure enhancements and zoning adjustments in hamlets throughout the County that could produce expanded development potential.





PROTECTING OUR LAKES

Since 2017, the Warren County Planning Department has submitted funding applications and overseen the implementation of critical water quality projects in the Lake George and Schroon Lake watersheds as well as assisted with water protection initiatives throughout the County.

Septic Initiatives and Program Expansion

Warren County received \$400,000 from NYSDEC in septic replacement funds for an expanded list of waterways. Warren County Planning will continue to administer the Septic System Replacement Program and continue to request additional funding to further improve water quality conditions throughout the County.


The Warren County Planning Department staff attended these meetings as an opportunity to interface with other groups that are involved with understanding and promoting water quality protection. Additionally, WC Staff presented at two of the committee meetings discussing Milfoil Harvest Data and the CD3 boat cleaning system unit on Schroon Lake.

Pilot Program for Schroon Lake

In June of 2024, Warren County placed a portable CD3 waterless cleaning system at the Horicon boat launch and the Schroon Lake boat launch. The unit allows for boaters to utilize an unmanned station to clean their boats and hopefully play a role in reducing the spread of aquatic invasive species. The program will continue in 2025.



ARPA ADMINISTRATION



As part of the Federal American Rescue Plan Act, Warren County was awarded approximately \$12.4 million to support economic and community recovery from the coronavirus pandemic. The ARPA Advisory Committee was formed for the purpose of making recommendations to the Board of Supervisors about how to best use the funding.

Planning Department staff serve on the ARPA Advisory Committee and several additional staff members supported the operations of the Committee. Facilitating the distribution of ARPA funds and providing support for the committee was a major task for the Planning Department in 2024: six percent of the department's overall staff time for the year was spent on ARPA related tasks.

Department staff tracked award recipients, the reporting of ARPA funds spent, and the documentation to support the expenditures. Staff coordinated with the County Attorney, Treasurer and County Administrator to make sure that spending decisions were legal and accountable and filed required quarterly and annual reports to the US Treasury.

Staff continue to work closely with applicants and awardees to develop projects and effectively use ARPA funds. As of end of 2023, there have been 72 ARPA projects completed out of the 90 awarded.



HOUSING STRATEGY

In Fall of 2023 Warren County Planning released the Housing Needs Assessment and Market Demand Analysis. During 2024, Planning staff worked with a consultant to develop a strategy to start tackling housing issues.

- Review of existing plans
- Community goal-setting via comprehensive planning process
- Determine highest impact use of existing County resources






LETTERBOXING

In 2024, the **Letterbox the Bikeway** Letterboxing Passport and Warren County Bikeway Map was launched! Letterbox the Bikeway consists of ten letterboxes in historic locations along the Warren County Bikeway between Lake George and Glens Falls. At each location, participants search for a hidden, weather-proof box, with a logbook, a hand-carved stamp, and an inkpad.

We had another successful year, with roughly 3,000 new Letterbox the Bikeway and 1,100 Historians' Challenge passports distributed throughout the County. We had 51 Letterbox the Bikeway finishers and 15 Historians' Challenge finishers in 2024, including multiple families who traveled to Warren County from out of state to complete the challenges. We continued to receive many positive comments from finishers, including one from Janet in Massachusetts, who writes "...I have greatly enjoyed exploring Warren County. We have had a wonderful time seeing new places. We very much appreciate the work you have put into this and hope to continue exploring." Nancy in Round Lake shares "thank you for providing this fun way to explore Warren County. We have made it an annual tradition."



STORIES FROM OPEN SPACE

The Stories From Open Space team worked with communities throughout the county during 2024 to help bring history alive. Our student interns Dominic Giordano and Sam McGarrahan collaborated with the president of the Hadley-Luzerne Historical Society to expand on the community's popular Lantern Walk Tour, using AI technology to let historic characters from the area tell stories in their "own" voices. Look for more to come on this exciting project in 2025. In the town of Thurman, the SFOS team narrated the story of the Crane Mountain Fire Tower and assisted in the fire tower cab's move to a new home at Martin's Tree Farm. Additional content focused on the eclectic group of artisans and farmers sharing their wares at the Thurman Fall Farm Tour, and plans are underway to expand content to include Thurman Maple Days in 2025.

Intern Annie Kiernan finished up her work about a proposed dam at Tumblehead Falls, working with historian Mike Prescott and using GIS technology to illustrate what Schroon Lake would have looked like if the dam had been built. In February, Stories From Open Space partnered with community members from North Creek to help celebrate the 90th anniversary of the Snow Train with a well-attended group presentation and discussion titled "How Skiing Came to North Creek".

In October, the Stories From Open Space team was honored with a Wild Stewardship Award from Adirondack Wild: Friends of the Forest Preserve, the organization Warren County resident Paul Schaefer launched in 1946 to uphold the Forever Wild clause of the New York State Constitution. The award recognized Warren County's work to promote the Forest Preserve as an asset for heritage tourism.


Our Stories From Open Space team officially launched the Explore Warren County app in the Spring of 2024. The app is available for free in the Apple and Google Play stores and was downloaded by over 2,500 users during 2024. Explore Warren County includes three GPS-triggered audio tours, including a driving tour through the First Wilderness, a walking tour of North Creek, and an audio accompaniment to our Historians' Challenge Letterboxing Trail. Additional tours are currently being developed for release in 2025.

The app also provides easy mobile access to our Recreation Mapper, which includes information about every public recreation asset in Warren County.

WE COLLABORATE AND PARTNER

Pro-Housing

Warren County assisted the Town of Hague, Horicon, and Johnsburg in obtaining Pro-Housing status. We will continue to assist communities interested in applying for or maintaining their certification.



Warren County Planning Group Meetings and Trainings

Warren County re-established regular County-wide planning and zoning meetings and trainings. These are intended for planning and zoning practitioners and board members throughout the County to provide an opportunity for conversation, collaboration, and continuing educational opportunities.

Two meetings were conducted in 2024. Into 2025, Warren County plans to continue and expand these opportunities.

We Partner

Working with local organizations towards common objectives is a backbone of the Department of Planning's philosophy of collaboration. In addition to supporting the towns in various planning and community development initiatives, the department worked closely with numerous agencies and departments in 2024, including the Sheriff's Department, the Public Affairs director, the County Administrator's office, the Office of Emergency Services, the Office of Aging, the Department of Public Works, Parks and Recreation, Real Property, Tourism, Board of Elections, Treasurers office, County Historian, the Regional Planning Board, A/GFTC, the Lake George Park Commission, and the Soil and Water Conservation District.





CLIMATE TASK FORCE

Climate Smart Task Force

In July of 2024, the Warren County Board of Supervisors officially reappointed members to the Climate Smart Task Force. The Warren County Climate Smart Task Force was established in 2019 to assist with development of strategies and actions to take to reduce greenhouse gas emissions and improve community infrastructure and systems in an effort to become more resilient to the impacts of global climate change.





Certified Bronze CSC

Warren County is a certified bronze Climate Smart Community and intends to reapply to be re-certified as a Bronze Level Community in early 2025.

Warren County Planning is available to provide technical assistance to any municipalities within the County seeking to obtain or recertify CSC certifications.

Climate Smart Community Coordinator

The Warren County CSC Coordinator supported the grant application for a composting pilot facility through the NYSDEC Climate Smart Communities Grant Program. The grant was successful with \$100,000 awarded. Additionally, CSC Coordinator supported WC Public Works in the application submission of a NYSDEC Municipal Waste Reduction and Recycling Education Grant.



REGIONAL PLANNING BOARD

The Planning Department continued its productive working relationship with the Lake Champlain Lake George Regional Planning Board during 2024, both providing and receiving assistance with numerous projects. The LCLGRPB reimburses department staff for time spent on GIS projects.

Technical Assistance and Map Requests



GIS staff has spent a creditable amount of hours assisting the Lake George Lake Champlain Regional Planning Board with various mapping requests throughout 2024. Some of the projects the department has aided with include New York State Department of Environmental Conservation's (NYSDEC) Drinking Water Source Protection Program (DWSP2) for the Town of Bolton, a series of maps for road salt reduction in Warren County, and a series of maps illustrating plow routes in Washington County. In addition, staff completed an online dashboard of proposed water quality projects within the Lake Champlain Watershed and created a crowd-sourced mapping platform for reporting areas with no cell service.

BROADBAND



BEAD Initiative Status



New York State's plan for expending approximately \$664 million from the Broadband Equity Access and Deployment (BEAD) Program through the National Telecommunications and Information Administration (NTIA) was approved and the Request for Applications for broadband providers is currently open through February 7, 2025. Warren County has three grant areas that providers may bid on. Successful bidders will receive grants for terrestrial broadband deployment to unserved addresses.

Broadband Support



Warren County GIS has been instrumental in collecting, analyzing, and presenting broadband data to advocate for federal and state programs that align with local needs. By mapping service gaps, identifying underserved areas, and providing clear visual data, GIS has helped inform decision-making and guide infrastructure investments to improve broadband access across the county.



GEOGRAPHIC INFORMATION SYSTEMS



101 E-911 ADDRESSES ASSIGNED

Warren County GIS is comprised of two full-time and one part-time staff, responsible for maintaining the County's GIS data sets and online GIS presence, including the Community Map, Imagemate Online, the Recreation Mapper and several other widely used applications. In addition, GIS staff has responsibility for assigning e-911 addresses and updating and maintaining the address point, road centerline, and district boundary data used in the County's e-911 Call Center, as well as in other applications. GIS staff also collate and provide demographic data on request in support of numerous projects and agencies.

Routine GIS maintenance of basemap data and applications accounts for approximately a quarter to a third of staff GIS time, with the remaining time spent in support of Planning Department projects and projects for other departments and agencies. Over the course of 2024, Warren County GIS provided assistance to Board of Elections, DPW, Office of Emergency Services, Parks and Rec, Real Property, the Treasurer's office, County Historian, County Administrators Office, Office for the Aging, Sheriff, as well all of the County's municipalities, and Warren County Soil and Water. In addition, Warren County GIS has contracts to provide technical support and mapping assistance to the Adirondack/Glens Falls Transportation Council, the Lake Champlain/Lake George Regional Planning Board, the Lake George Park Commission, and the Lake George Land Conservancy.



MAJOR GIS PROJECTS

ArcGIS Pro Transition

GIS staff transitioned the maintenance of the County's tax parcel data from ArcMap software, which is being retired, to ArcGIS Pro software. This was a labor-intensive project that staff were happy to be able to complete inhouse. The transition went smoothly and the tax maps are now being successfully maintained in ArcGIS Pro. 2025's hard-copy tax maps will also be generated using ArcGIS Pro for the first time.

Entering the Realm of 3D GIS

GIS staff spent a substantial amount of time in early 2024 becoming more proficient with 3D GIS and learning ArcGIS Urban software. This software will allow staff to model planning and zoning scenarios in 3D and will be used extensively in the County's Thriving Hamlets initiative.

Support Planning Department Intatives


GIS staff provided expanded support in 2024 for numerous Planning initiatives, including the Warren County Comprehensive Plan, the Multi-Use Trail Study, the Outdoor Recreation Economy Strategic Plan, and the Housing Strategy. Support for the various plans included website maintenance, preparing posters and digital materials for public workshops, summarizing public survey results in an interactive dashboard, collecting data, performing various data analyses, providing support for field data collection, and preparing numerous maps.

Short-Term Rental Analyses

GIS staff, using data collected by the Warren County Treasurer's Office combined with Real Property data, performed a detailed analysis of short-term rental trends in Warren County. This analysis was added to the County's Housing website and presented to the Economic Growth and Development Committee. GIS staff also performed data analyses for several municipalities to assist them with making data-driven decisions as they look to establish short-term rental regulations. GIS staff look forward to continuing to collaborate with the Treasurer's department and IT staff to improve short-term rental data collection procedures in 2025.



ONGOING GIS PROJECTS



Lake George Village and Glens Falls Infrastructure Data Support

City of Glens Falls Hydrant Map

GIS staff redesigned geodatabases for the Village and City for their water and sewer departments. This enabled the departments to start or continue maintaining data out in the field digitally using mobile devices. GIS staff set up devices and offered training for workers to be more efficient in their roles. GIS staff also designed a hydrant flushing application which allowed city workers to collect real-time data as they were performing their semi-annual hydrant flush. This data will allow increased efficiencies in hydrant maintenance.

In addition, GIS staff provided continued support for the County's municipalities with the EPA's mandated lead pipe inventory program. Support included providing a Survey123 form for homeowners to use to test their pipes and report their findings, as well as a dashboard for municipal staff to use to access and download reports.

GIS staff also provided continued technical support to the City of Glens Falls Highway Department by creating pedestrian facilities and pavement scoring dashboards. Having access to this data allowed City staff to make data driven decisions for scheduling repaving, sidewalk and curb work. Additionally, GIS staff assisted with providing a platform for City staff to keep the data up to date moving forward.



CONTINUING GIS PROJECTS

Pro-Housing

GIS staff assisted planning staff with compiling data for municipalities to become Pro-Housing Communities. Offered by New York State's Office of Homes and Community Renewal, being a Pro-Housing Community enables localities to apply for certain key discretionary funding programs such as the Downtown Revitalization Initiative (DRI), the NY Forward Program, etc. Throughout 2024, planning and GIS staff together helped the municipalities of Hague, Horicon, and Johnsburg become Pro-Housing Communities.

GIS Trainings and User Groups

GIS staff collaborated with the Warren County Soil and Water Conservation District to re-establish regular GIS user group meetings. These training classes, taught by GIS staff, occur monthly at the Warren County Soil and Water Conservation District office and provide an opportunity for GIS users from local organizations including the County, regional Soil and Water Conservation District offices, and the Lake George Land Conservancy, to meet together, collaborate, and gain expertise using various components of GIS technology.

WARREN COUNTY PLANNING AND COMMUNITY DEVELOPMENT

Grant Award Administration and Implementation

In 2024, Warren County Planning was awarded grant funding for eight (8) different projects. 2025 will continue the implementation of awarded grants with varying level of staff involvement.

Housing Strategy

Warren County Planning will focus on implementing the actions from the County Housing Strategy that were identified as near-term, actionable priorities for the County to advance in 2025.

Thriving Hamlets

Warren County Planning and GIS staff are responsible for the development and implementation of Thriving Hamlets. GIS staff will continue developing the existing hamlet conditions that are being utilized in the analysis through 2025. Planning staff will begin municipal outreach on the project and will utilize feedback to further refine the list of hamlets that will be selected for the full buildout analysis.

WC Brownfield Inventory

The Warren County Brownfield Inventory will identify vacant and underutilized properties across the County. Warren County staff will be directly involved in the analysis and development of this inventory.

Plan Completion and Implementation

2025 will mark the finalization of a number of planning documents including the Warren County Comprehensive Plan, the Outdoor Recreation Economy Strategic Plan, and the Multi-Use Trail Study. Staff will utilize these documents to guide department/staff activities, programs, and initiatives.

Grant Preparation and Assistance

In 2024, Warren County Planning prepared and submitted fourteen (14) grant funding applications. Staff will continue to support County departments and municipalities in applying for state and federal grant funding programs. The finalization of plans in early 2025 will provide a strong basis for grant funding requests.

Support for Local Planning

Warren County Planning and GIS will help municipalities as they seek Pro-Housing certification and as they develop Comprehensive Plans over the course of 2025. Many of our municipalities won competitive planning grants and our staff will be assisting to ensure that their projects are successful.

Grant Award Implementation



Warren County GIS will assist with grant projects awarded to the department in 2024, with primary focus on Thriving Hamlets and the Brownfield Inventory. The Thriving Hamlets project will see staff continue to expand the use of 3D GIS to assist local communities with visualizing potential infill development and zoning regulation changes in their hamlets. The Brownfield Inventory will take advantage of in-house expertise and historical knowledge, combined with research and collaboration with municipal staff, to create a cutting-edge online inventory of brownfield properties for potential future redevelopment.

Technical Support



Warren County GIS will continue to support the municipalities, partner organizations and county departments with projects and technical expertise during 2025. Special focus will be given to supporting the City of Glens Falls as it seeks to increase the use of GIS in its Public Works, Buildings and Codes, and Sewer and Water departments. Additional support will also be provided for the County's Real Property Department as it brings a new Tax Map Technician on board and transitions to maintenance in ArcGIS Pro.

Application Redevelopment



Technology changes quickly, and GIS is no exception. Staff will spend time during 2025 redesigning the widely used Community Map in a new development platform.

Also on the list for redevelopment is the Recreation Mapper, which will be redesigned and expanded in support of recommendations made in the Outdoor Recreation Economy Strategic Plan.
