2.) Glens Falls Hospital – Hazard Vulnerability Assessment/Medical Surge Exercise Review

Hazard Vulnerability Assessment (HVA)

The Glens Falls Hospital HVA identifies potential emergencies or other circumstances that may impact the hospital and the community. It includes the direct and indirect effects these emergencies may have on the organization's operations and the demand for our services. Glens Falls Hospital (GFH) HVA reviewed annually by the multidisciplinary Emergency Management Committee and revised as needed. The HVA is brought to this committee today for review and any recommendations. The GFH HVA analysis includes the current Warren and Washington County Emergency Preparedness Assessment (CEPA). The GFH off campus sites develop individual HVAs that generally have the same potential hazards with each site including vulnerabilities/assets specific to their location and population served. The Emergency Management Team reviewed the current HVA and revised as needed based on:

- Weather predictions
- Crime statistics –local and national
- Facility structure and events
- Public Health information
- Regulatory guidance from DNV, DOH, CMS, and CDC guidance

Revisions reviewed during meeting.

Top 5 Emergency Vulnerabilities as determined by Probability x Impact:

- 1. Patient Surge- medical, trauma, evacuation of other healthcare facilities (probability & impact)
- 2. Mass Casualty incidents –transportation/violence (probability & impact)
- 3. Information System Failure-intentional or accidental (impact)
- 4. Blizzard/ice storms (probability & impact)
- 5. Pandemic (impact)

These vulnerabilities consistent with county CEPA and regional HVAs.

Exercise

NYSDOH Medical Response Surge Exercise (MRSE) 4/23/24.

Scenario a surge of patients with exposure symptoms present to hospitals across the state. They all attended mass gatherings during the eclipse yesterday.29 regional hospitals determined the number and type of patients they could receive. GFH activated Code HICS and established the Hospital Command Center. HICS team determined location of 40 admissions. Patient Access reviewed eFINDS (NYS electronic patient tracking system), in the event an Adirondack Hospital was being evacuated. Interoperable communication included HCS HERDS system, phone contacts, 2-way radios, Everbridge mass notification system, HEOCC contacts and amateur radio connectivity between GFH command center and Warren County OES. Case Management contacted area Nursing Homes for possible decompression locations. Pharmacy reviewed Chempack contents and Cipro & Doxycycline availability. Facility Response Team staged decontamination tent & inventoried resources. GFFD representative observed and provided recommendations.

Some Lessons learned - Hazmat equipment, ED being restructured (hazmat storage area); contact numbers updates; could accommodate 651 medical patients

Dan indicated Warren County would act as a call center in the event of a medical surge. More questions about where the message would come from and who to include – more questions need to be answered which is the goal of these tests to determine gaps in the planning.

- 2 primary sites multiple sites secondary community centers looking for places that have large areas to meet; 12 sites keep up to date
- Monitoring the measles outbreak in this area 0 in this area will be monitoring as the tourist season ramps up.
 Vaccination is 83%
- Highly Pathogenic Avian Influenza nothing here but the state is monitoring this someone from public health will be sitting in on this more of a concern than an issue 10-12:30 April 25
- Dr. Leach gave a general overview of the Avian Influenza, not at all like at a COVID level.
