LEPC UPDATES

Commodity Flow Study Update to the 2016 plan - in-depth analysis of hazardous materials (hazmat) transportation and considers multi-modal transportation.

The HMCFS represents the work of both the ARHC and the seven counties under its jurisdiction – Clinton County, Essex County, Franklin County, Hamilton County, St. Lawrence County, Warren County, and Washington County.

- **Objective 1:** Identify primary hazmat transportation routes.
- Objective 2: Determine hazmat types, shipment frequencies and modes of transportation
- **Objective 3:** Assess local facilities that utilize hazmat and their impact on hazmat transportation within the planning area.
- Objective 4: Evaluate potential hazmat transportation issues and long-term goals to enhance regional preparedness against hazmat incidents

2.) Public Health EPR Update - Dan Durkee

COVID is back and impacting long term care facility.

Heat events update:

- 1. Heat Advisory has been revised & updated.
- 2. Area of concerns are schools, which most are not air conditioned. Classroom temps can go as high with no number to send kids home.
- 3. Hospital & Nursing homes are both dealing with heat issues. Hospitals ER filled with patients.
- 4. Action steps taken:
 - 1. guidance from School Supt.
 - 2. schools did ½ days
 - 3. Social Media posts
 - 4. Home care agency- numerous check-ins.
 - 5. Cooling centers closed due to Juneteeth holidays.
 - 6. Updated Cooling Centers stations on map.

3.) Committee Member Updates:

Christina Mastnanni, DSS

DSS – Storm relief update SNAP Food Loss relief program due to storm damage has been extended to August 14th for people to file a claim. Also, there is the potential for relief money to be available for people who qualify for other losses like clothing, furniture and damage to homes. Contact DSS for more information. DSS has cooling assistance money (similar to HEAP) that is still available to help people afford things like fans and air conditioner if they qualify.

Jamie Schrammel HAZMAT

Hazmat team is working towards accreditation. Close to being finalized waiting on paperwork to be completed and filed. Completed annual Hazmat training with hazmat team.

Rob York Mental Health

Office of Community Services is looking to rebuild the County disaster mental health team. Currently only about 13 people are on the team. A retraining for people interested in the disaster mental health team will be happening on October 29th with psychological 1st Aid which is open to anyone and on October 30th with clinical disaster mental health for clinicians only. Also mentioned that NYS office of Mental Health maintains a Disaster Mental Health team that can be requested when local resources are overwhelmed or unavailable for large scale disasters

Peter McKee, Red Cross

Has been providing assistance in Rome NY due to severe weather staffing 3 temporary shelters. Has staffed standby by shelters for events including the Belmont. Will be working on setting up mock temporary shelters in all of the Counties in Eastern NY to strengthen readiness. Has also been providing shelters for residential fires that impact 10 or more people. They have been very busy and are in a constant state of response due to multiple factors.

Jonathon Samiof- DHSES

They have been working on event planning for large events in the region including the Belmont which will be returning next year. Have completed several County Pilot CEPA reviews and will be tweaking things based on lesion learned. The goal is to get other Counties scheduled to complete the CEPA process and will be contacting Counties including Warren and Washington once the CEPA changes have been made.

Corey DiLorenzo - NYSPH

Spoke about Boar's Head recall and camps issues plus inspection. Dealing with a lot of seasonal issues.

Ashley Rivers - WCOES

Will be holding their bi-Annual meeting with national grid, participated in the Aviation Mall TTX. Working on Mass Fatality Plan Updates, need to set a meeting with Coroners and Funeral Directors to work out a few details, CEMP is in process of being updated. Not a lot of changes expected. Working on Chempack Plan Update with GFH and PH. Developing a UAS Policy for Drones for usage in damage assessment, event surveillance, search and rescue operations etc. Conducting a 7 County Commodities Flow Study. Starting a CERT Team in the fall Oct or Nov.

Mallory Lloyd - Washington County Public Health

Dealing with upcoming Washington County Fair. Flu is on radar, and COVID is on the increase.
