4/7-4/9 Rain event – Multiple road closures – with one long duration closure due to extent of repairs 4/19 – Late season snow storm, over 12 inches of heavy wet snow, resulting in over 14,000 power outages in mostly the north and western municipalities in the county. Dan Durkee, Public Health update

- 1. Seeing uptick in COVID cases. Still receiving many questions and we are doing the best to get information out.
- 2. Tourism season beginning- lots of questions, and need for resources. Lots of camp grounds closed to COVID are reopening.
- 3. Working with Double H providing resources and supplies.
- 4. Flu numbers are up. With COVID we are a dual threat. Both are straining our resources.
- 5. NY State looking into Warren County POD sites, and the need to update the contact information, and other information. PH Staff will be visiting various locations.
- 6. Booster Clinics running for 2nd dose of Boosters. Approx. 80 per clinic so we are getting good numbers. State operating site at Aviation Mall on Tuesday, Thursday, and Saturday (no Moderna at this site)

Member Updates

Derrick Owens, Homeland Security – spoke about inspections at COVID sites, and ShieldsUP cyber security concerns with the events in Ukraine. Mike Tripodi, American Red Cross – spoke about next month program, Sound Alarm. which is helping to install smoke detectors in eastern New York and to educate and provide resources to families. Told to call Red Cross for installation. Also, talked about many summer camp programs and getting ready for all the programs.

Donald James Red Cross -1st live meeting last month in 2 years at the Red Cross office in Glens Falls. Very positive for all involved. He also spoke about the upcoming SkyWarn trainings available and hoped for good attendance.

Sandy LeBarron Finch Paper- Watching COVID numbers and preparing for Homeland Security inspections.

Robert Higgins DEC – Stocking ponds, turkey season coming soon. Spoke about avian and its impact on wild bird populations. So far, the impacts have been limited in New York with only a few cases. He asked people report any suspicious die-offs of waterfowl and wild birds to DEC.

Dr. Ellis NY Ag & Markets – Announced his plans to retire in June, but that he would still like to help out if needed as a volunteer. He also spoke on the Avian Flu and the importance of reporting any type of illness in domestic (turkeys, chickens etc.) flocks no matter how small a flock is. He recommended that people with domestic flocks take some safety measures to keep wild birds from eating feed and drink from water sources for domestic flocks. He recommended keeping feed/water in shelter under a roof or installing netting to keep wild birds out. He also stated that hunters do not have to worry about contracting avian flu should they "take" a wild turkey during the hunting season. However, he did recommend that when dressing a wild turkey, hunters wear gloves and eye protection to reduce exposure. He also said that other poultry producing States have depopulated large flocks of birds to try and stem the spread of avian flu.

Dan Durkee thanked Dr. Ellis for his service and his participation on the Warren County EPR Committee and wished him well in his retirement.

James Phalin, DHS – talked about ShieldsUp cyber security program (see notes from Derick Owens). ChemLock is a voluntary program which provides no-cost services and tools to chemical facilities to help them better understand risks and improve their chemical security posture.

- On-site chemical security assessments and assistance
- ChemLock fact sheets, best practices, and guidance documents
- Chemical security exercises and drills
- Chemical security training courses

Charley Mallet, Hudson Headwaters Health Network— new offices in Glens Falls will include a health center and Senior Day Care in near future late 2023 early 2024. The senior daycare will be somewhat separate from HHHN health center oversite. Charley is working on plans for emergency preparedness to meet the regulatory requirements of New York State for the unique programming anticipated to be provided by the senior day care. Preparing for community education with a start by year end.

Mike Walker, Capital Region BOCES- watching COVID numbers, concern there up. Stop the Bleed training coming soon to the Warren County schools that are members of the Capital District BOCES.

Shannon Finegan, NYS OHEP – Thanked Ann Marie for information. Watching COVID numbers, delivering test kits to School. Test sites at Crossgates, and Aviation Malls are operational. Training Plan for Warren County.

Dan closed the meeting by thanking everyone for their time and reminding them that next meeting has been scheduled for July 27^{th} .
