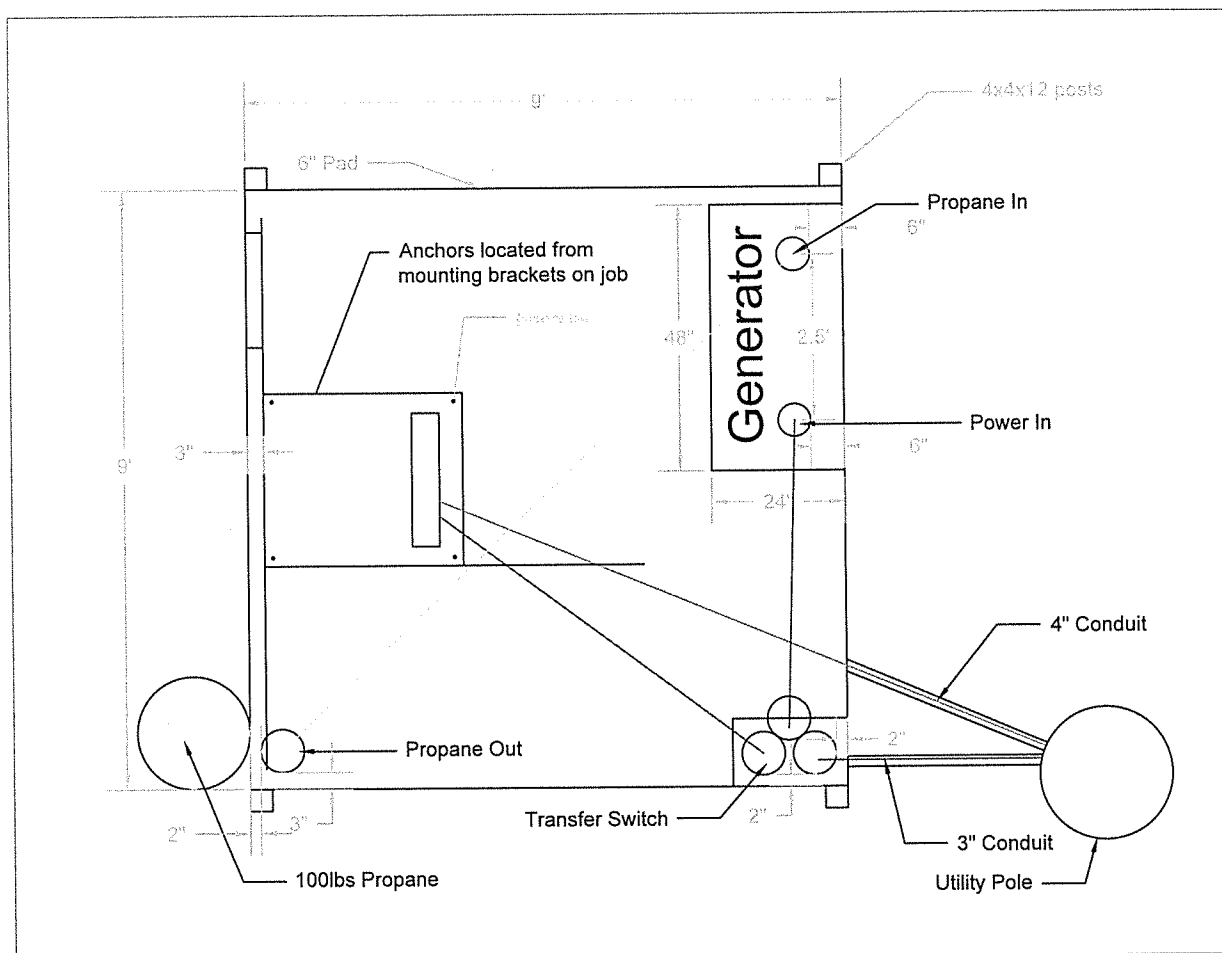


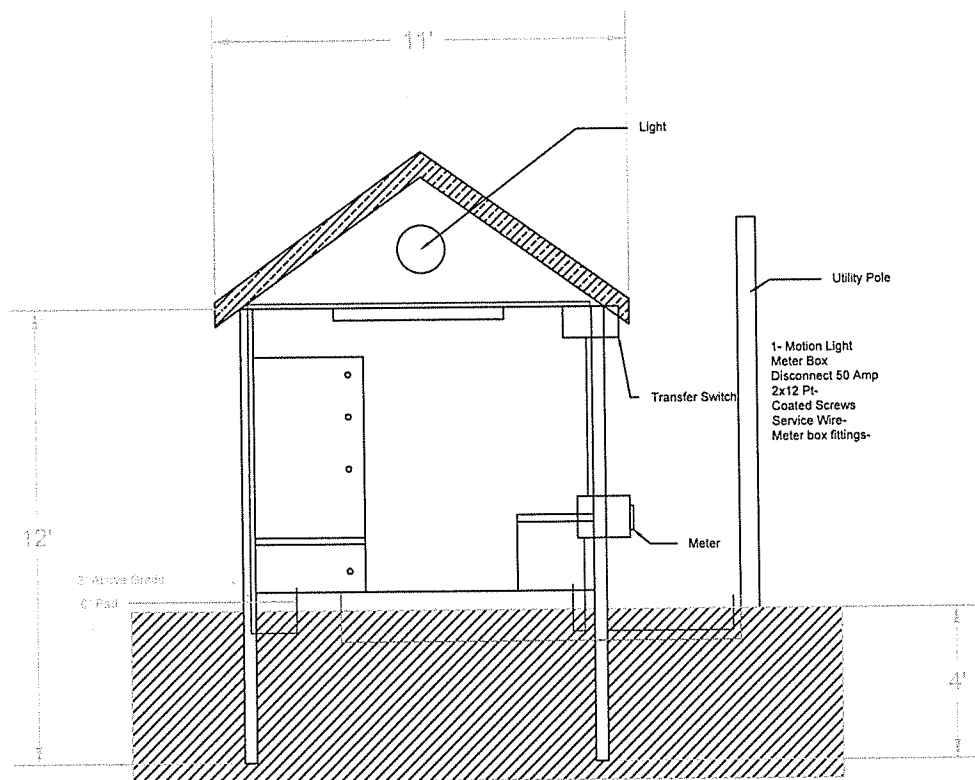
Proposed Location of Cabinet

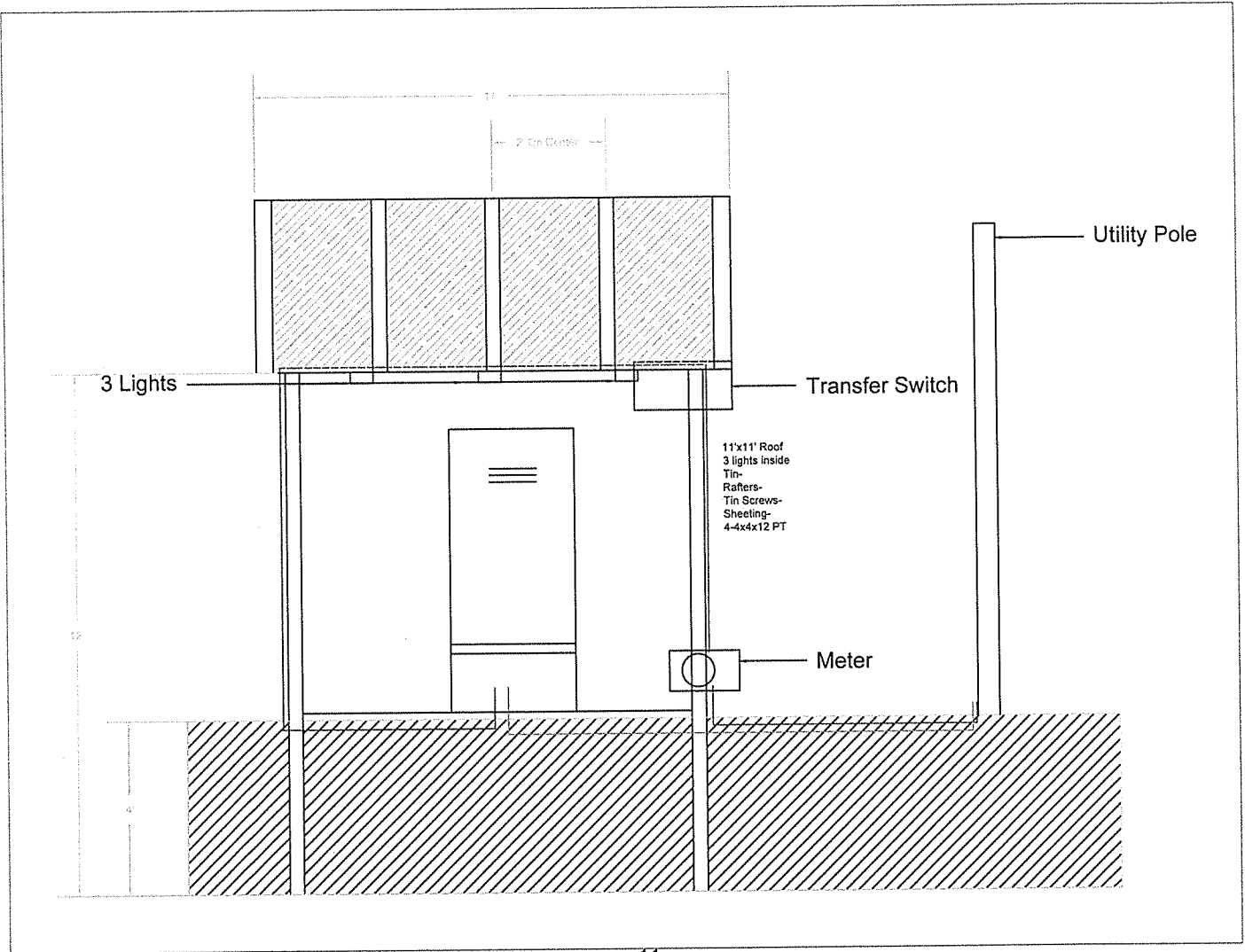

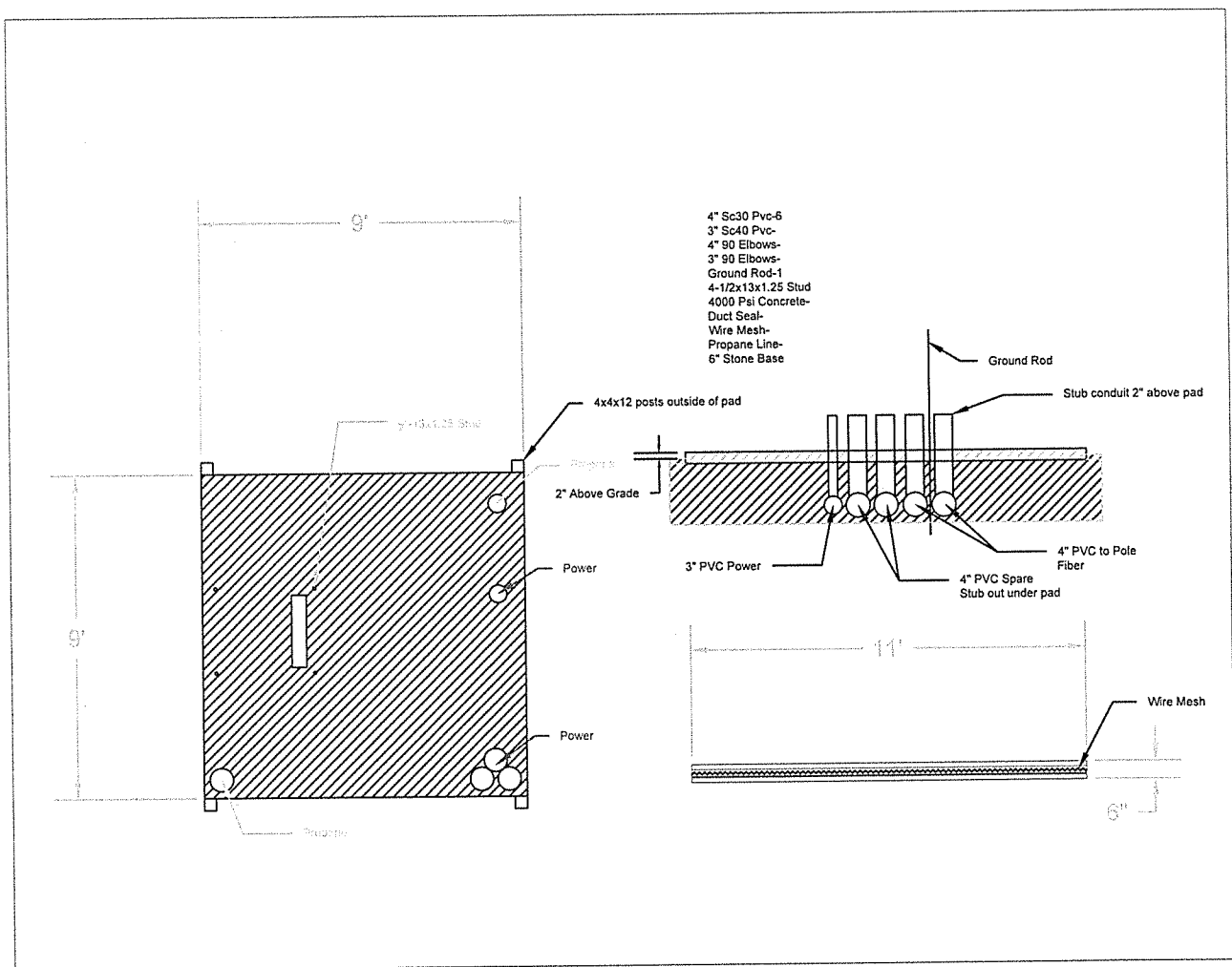


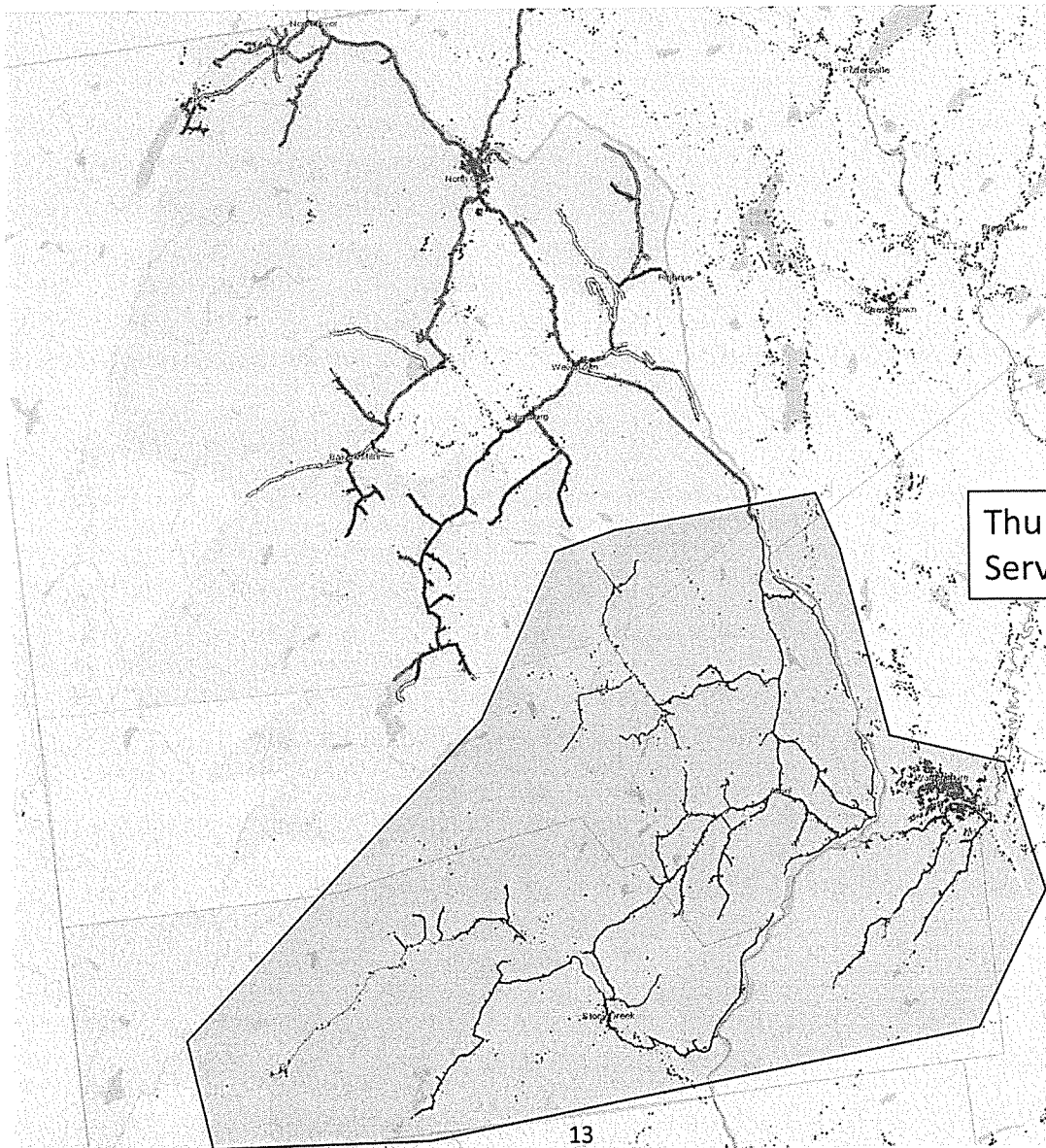




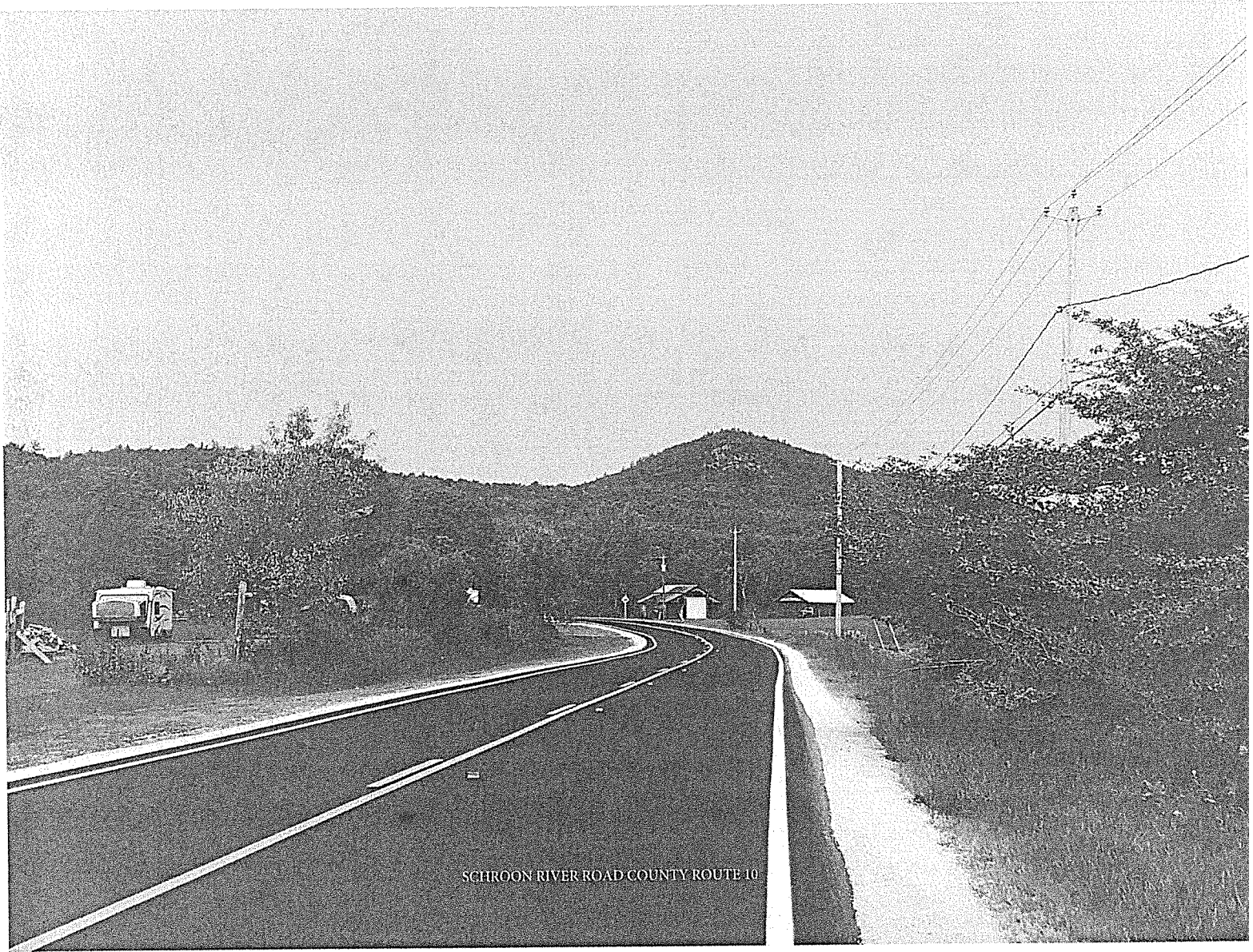








Thurman Station  
Service Area

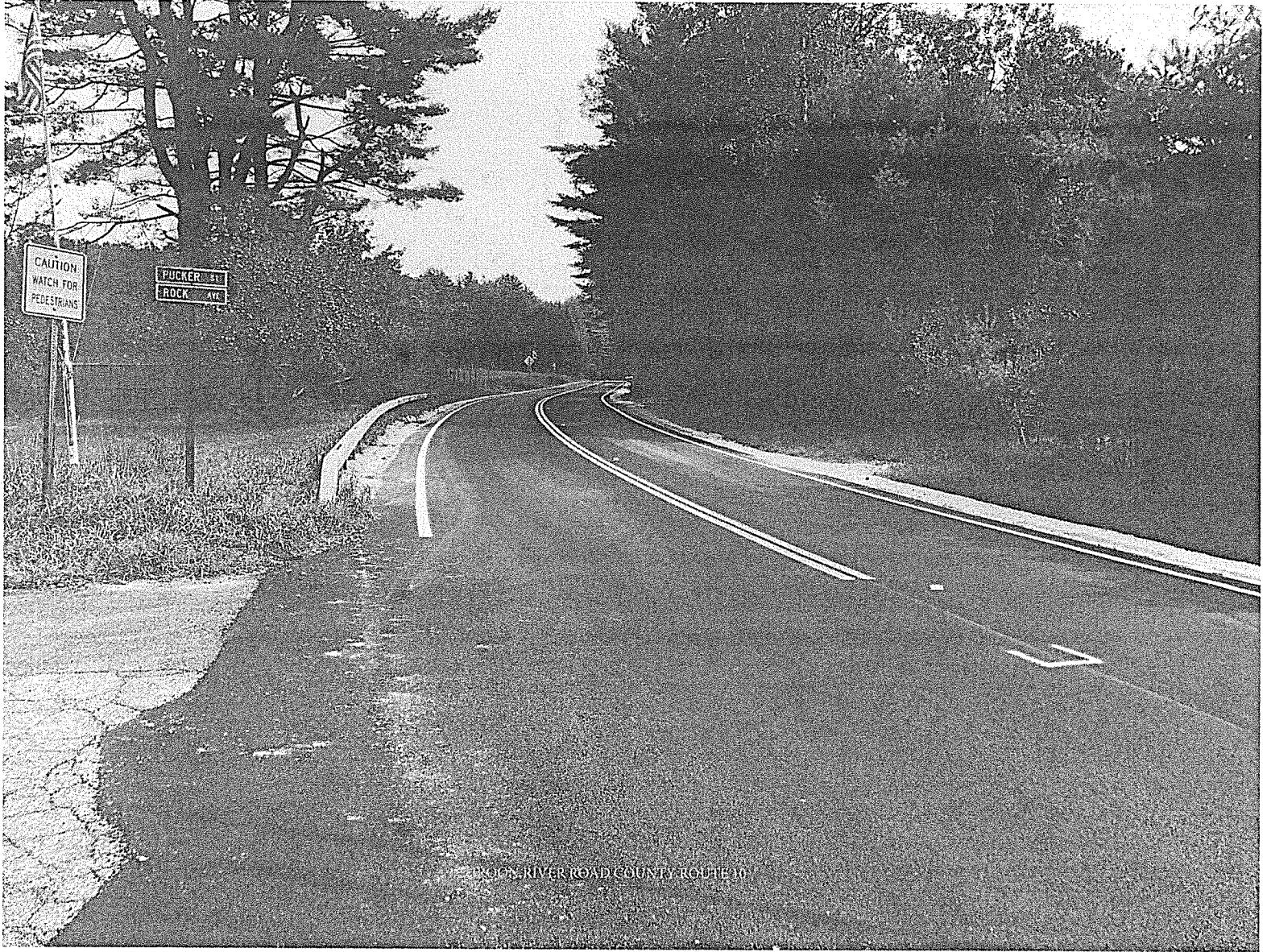


SCHROON RIVER ROAD COUNTY ROUTE 10
