- 1. Welcome & Call to Order: Chair, Peter McDevitt welcomed everyone and called the meeting to order at 11:08 a.m. Roll call and quorum established.
- 2. **Approval of Minutes:** The Minutes for the April 20, 2023 Regular Monthly Board Meeting were approved unanimously, motion made by Eugene Merlino, Seconded by Mark Smith; roll call taken.
- 3. **Financial Update**: EDC Finance/Compliance Director Dumouchel reviewed the WCLDC April 2023 Financials; motion made by Robert Landry to approve, Seconded by Craig Leggett; roll call taken, approved unanimously.

Discussion regarding CD investment options/schemes ensued. Board approved unanimously to investment in staggered CD's in the amount of \$400,000. Motion made by Gene Merlino,

Seconded by Mark Smith; roll call taken, approved unanimously.

The issue of the outdated LDC Loan Application on the Website was discussed. The County was asked to take this application off the website while staff has opportunity to revise the application for re-posting. A new draft application will be presented to Board in future.

4. **President & CEO Report:** President Siplon addressed the Board indicating an unprofessional and offensive inquiry that was made to a staff member by an unnamed inquirer and the stance that nothing of the sort would be tolerated for any staff member of the LDC. Pursing advice from Counsel for potential next steps.

President Siplon spoke of the recent resolution passed by the Warren County Board of Supervisors to join the Capital District Transportation Authority. CDTA will merge with the Greater Glens Falls Transit. Discussion regarding potential ways the LDC could be a partner in public transportation as it expands our regional economy.

- 5. Other Business: Donnie DeVito, President/COO of Kirsh Helmets presented to the board regarding company profile, background, future. Presented sample helmet and extended invitation for members to visit facility. Established outline of future of the company and justification for the furtherance of LDC loan for the organization and thanks on behalf of the Company.

  - 2. **Financial Update**: EDC Finance/Compliance Director Dumouchel reviewed the WCLDC May 2023 Financials; motion made by Craig Leggett to approve, Seconded by Mike Wile; roll call taken, approved unanimously.

Further discussion regarding CD investments at Glens Falls National Bank. Board approved unanimously to invest in 6 Month CD in the amount of \$200,000. Motion made by Craig Leggett, Seconded by Mark Smith; roll call taken, approved unanimously.

### 3. President & CEO Report:

President Siplon addressed the board that EDC was approached to place an ad for marketing the WCLDC loan program in partnership with the EDC. The marketing involves a ¼ page ad in the program for the Glens Falls July 4<sup>th</sup> Celebration program. The total cost of ad is \$250. While no monetary participation was requested, the Board agreed to contribute 50% towards the cost for a total of \$125.00. Motion made by Mike Wild, seconded by Mark Smith; roll call taken, approved unanimously.

President Siplon summarized meeting with Business Review Committee (Banking) meeting and their discussion regarding the options for a loan modification for Kirsh Helmets, Inc. The loan modification extends the previously approved forbearance period by an additional 12 months. Motion made by Mike Wild, seconded by Brad Magowan approving the new loan modification for Kirsh Helmets, Inc; roll call taken, approved unanimously.

Robust discussion on potential support the LDC could provide to existing or area septic firms to increase rendition capacity as well as available housing opportunities for support. Both areas continue to be explored for further review by the full board with a decision target this year.
